

Dear Family,

Congratulations again on receiving your referral acceptance!

We look forward to working closely with you throughout the travel phase of your adoption process. We want to make sure your trip to China is a beautiful and worry-free experience. At this time we can only do preliminary planning. From the day that your referral acceptance (RA) is sent back to China, your Travel Approval (TA) will typically arrive 2-4weeks later.

Once we receive your TA we will call you and be able to discuss potential travel dates and request a Consulate Appointment for your family. Once the appointment has been confirmed (usually takes 1-3 business days) we will be able to confirm your concrete travel dates and finalize your travel arrangements. Your family will tentatively travel 2 ½ - 4 weeks after receiving the TA. Please note these are tentative dates based on the most recent trend in TA arrival dates and could vary by as much as 1-4 weeks.

This is the most exciting stage of the adoption process, but it also takes a lot of work and planning on our part to complete. Please be patient and know that we will keep you informed of the details of your travel as they unfold. Email will be our main form of communication, so please make sure you have a functioning email account that you check regularly. Please inform me if you have another email address that you prefer for us to use.

Please be sure to read through the travel information throughout this packet as it will help you better understand what will happen during the travel stage of your adoption process. Once you have read through the travel information please complete the travel forms required for us to plan your trip to China. If you have questions while completing these forms, email is the best way to reach me. Once we have reviewed your travel forms, we will email you with instructions and next steps on obtaining your Chinese visas.

While waiting to receive your TA please be sure all traveler's have a valid passport. For any traveler who does not have a passport you will need to expedite their passport as they will need to apply for their Chinese visa with a current US passport. In addition, any traveler who has had a name change that is not reflected on their passport or has a passport that is 9 or more years old, will need to rush order an update or new passport. Passports must be at least 6 months from expiration in order to apply for a Chinese visa.

We look forward to working closely with you throughout this phase of your adoption process. Please be sure to read through the travel information thoroughly as it will help you to better understand what will take place in the weeks ahead.

## Travel Information



It is very important that each family checks their email regularly as this will be our main form of communication.

### **Travel Forms**

Please email/fax all required forms to Attn: Travel Coordinator at (888-466-8922) as soon as possible as we are unable to begin working on your international flights and in-country travel arrangements until we receive this documentation.

- □ Traveler Information
- Copy of passport photo page (for each traveler)
- Travel Preferences & America World Services
- □ AWAA Travel Release form (signed by each traveler over the age of 18 years old)
- □ Completed & signed Chinese visa application (for each traveler)
- □ Visa Payment form

### **Travel Meeting Conference Call**

There will be a travel meeting conference call held approximately 1-2 weeks prior to your departure date. Once the date of the conference call has been determined, we will email your family the time of the call. Typically calls take place in the afternoon and are always scheduled in Eastern Time zone. The call will provide you with a day-by-day breakdown of your adoption itinerary, including adoption appointment and paperwork specifics, as well as some general information on travel to China (packing, tipping, gifts/donations, and more). There will be a designated time at the end of the call to ask any questions that you may have that were not referenced in the Travel information or the hour long meeting.



America World uses four and five star hotels for all locations throughout your adoption trip. Hotel rooms in China are considerably smaller than American hotel rooms. Each room contains two beds and each bed is slightly larger than an American twin bed. Adjoining rooms may be requested however we cannot guarantee the availability of adjoining rooms until check-in.

When determining the number of hotel rooms needed in each location of your trip, please take into consideration that China hotels have a strict policy of 3 adults per hotel room. Each person who is 12 years of age and older is considered an adult. Each person who is under 12 years of age is considered 1/2 of an adult.

Any changes in number of hotel rooms desired and the number of travelers must be given to us in writing (or by email) by the time you confirm your flights with the Travel Coordinator. There is no guarantee that changes can be made after this point.

## **\$** Travel Dates & International Flights

### Travel Dates: Departure & Arrival Times

Each family will depart from their respective US airport departure city on a Thursday and will arrive into Beijing on a Friday. The official adoption itinerary will begin with sightseeing in Beijing on Saturday morning. Each family will depart from Guangzhou to return home the day after their Consulate appointment.

### **Booking International Flights through AWAA**

Once your family receives your Travel Approval (TA) as well as a confirmed Consulate appointment for your trip, we will work to finalize all international flight arrangements and will contact you within 1-2 business days to review and confirm your proposed international flight itinerary. If your family would like AWAA to arrange your international flights, please be sure to circle this preference on your Travel Preferences form (page 19). We will email you a copy of the international flight itinerary we have on hold for your family as soon as we have them completed. In order to guarantee the quoted airfare on the itinerary, the proposed flight will need to be finalized the same business day as airfare prices typically fluctuate overnight. All tickets are nonrefundable once purchased.

### Booking International Flights On Your Own

If your family will be booking your own international flights, please review the <u>International Flight</u> <u>Guidelines</u> and email a copy of your proposed international flight itinerary from the airline to the Travel Coordinator's email address. Please wait to finalize all flight reservations until we have officially reviewed and approved your family's international flights.

### **Frequent Flyer Miles**

Families who would like to purchase tickets with frequent flyer miles will need to plan their own international flights. It is possible to purchase upgradeable tickets if your family has a significant amount of frequent flier miles with an airline.

### **International Flights Seating Assignments**

Please be aware that America World cannot place seating requests for you. We are able to book tickets, but you will need to call the airline and request the seating assignments that you would prefer. In our experience airlines are not generally consistent with seating protocol. Sometimes they will allow you to make the seating arrangements beforehand; other instances indicate that you will be unable to do so until your date of departure. Our recommendation is to be flexible in this area and to contact the airline once the Travel Coordinator has informed you that all flight bookings have been made. Once your flights are booked, you can call the airline with your last name and flight number to arrange seating assignments.

## **\$** Travel Payments

There are separate portions of travel that will require payment individually:

- Chinese Visas
- International Flights
- In-Country Travel Package
- In-Country Adoption Expenses

For a detailed timeline of all travel expenses from Referral Acceptance to in-country, please reference the <u>Travel Payment Overview Chart</u>.

### **Chinese Visas**

If you have indicated that you would like to use AWAA as your visa courier service on the Travel Preferences form (page 19), each family will pay the "Total Amount Due" on the <u>AWAA payment site</u> under Visa Payment and include a printed copy of your online payment confirmation or a check made payable to AWAA with your mailed visa package to AWAA.

### **International Flights**

International flights must be paid with a credit card(s) of your choice and may be paid by the family and/or separately by each individual. Airfare will vary depending on the season of travel and airline. International tickets for travelers under 12 years of age usually cost about 75% of the adult fare. Payment for your international flights is due when your flights are booked. Your credit card information will be received and charged once we have confirmed your flight arrangements with you.

### In Country Travel Package

You will receive one package price per family group including any additional traveler(s). This package price includes all travel arrangements for the adoption trip including:

- Travel Coordination and Processing
- All In-Country Transportation (Ground & Air)
- 5 & 4 star Hotel Accommodations
- 4 group meals in Beijing
- Sightseeing
- Expert Guide Services
- Tips for Guides & Bus Drivers

This price is determined per family group and cannot be broken down or itemized. Depending on the season of travel, the package cost will range from:

- Adoptive Couple (includes the adopted child) = \$4,000 \$6,000
- Per Additional Traveler = \$1,500 \$2,000

Families adopting children with special needs or traveling in a small group could potentially pay a larger amount for their in-country package. The in-country travel package price will also vary depending on the season of travel and the number of additional travelers in the family's group. Each family is allotted to have up to 6 travelers total (not including the adopted child). An additional \$500 per traveler will be added to the seventh plus traveler(s).

The travel package price will be emailed to you about 1-2 weeks after booking your international flights. You will have at least 24 hours from the time you receive the price to pay on the <u>AWAA payment site</u>.

## **S** Travel Payments Continued

### **In-Country Adoption Expenses**

Each family is required to bring \$7,700 <u>in cash</u> with them to China to cover the expenses for your child. Cash must be free of marks, tears, or stains. The breakdown of the cash is as follows:

- > \$7,500 in clean \$100 bills
- > \$200 in clean smaller denominations

Adoption fees may vary according to the province and current exchange rate. Most fees are paid in Chinese currency.

The AWAA guides will assist your family in converting the US currency to Chinese currency once you arrive in China. Please do <u>not</u> convert any US currency until your guide has instructed you to do so.

Breakdown of Adoption Fees	Cost Range
Orphanage Donation	\$5,000 - \$5,500
Notarization	\$500 - \$700
Registration (Family Picture & Child Transportation)	\$100 - \$300
Child's Chinese Passport	\$100 - \$150
Child's Medical Exam	\$80
Child's US Visa	\$404

The Breakdown of Adoption Fees outlined above does not include money for adoptive parents' or additional traveler(s) food or personal purchases. We recommend bringing \$500-\$600 per adoptive couple to spend on food expenses and personal purchases during your  $1\frac{1}{2}$  - 2 weeks spent in China.

### IMPORTANT NOTE ON CUSTOMS DECLARATION

Families who will be traveling with \$10,000 or more in cash are required to declare the money and can do so at the airport or in advance by completing a "Report of International Transportation of Currency and Monetary Instruments" FinCEN 105 (former CF 4790).

### Schinese Visa Information

Visas are issued by the Chinese Embassy or one of the Chinese Consulates in the United States. Visa applications will only be accepted when submitted in person. Each family has the option to apply for their visas on their own, through America World, or through a private courier. Families applying for a visa on their own will want to reference the website for their respective Consulate/Embassy (depending on which state they reside) for further instructions and information. Participants who choose to use a private courier will want to contact their respective courier for instructions once their application is reviewed with the America World Travel Coordinator.

### AWAA Visa Courier Service

Once a family's travel preferences and visa applications have been reviewed with a Travel Coordinator, each applicant will be asked to submit the required items needed for each visa application to America World by a specific date emailed by the Travel Coordinator. America World will then act as a courier service on behalf of each family and process visas under the 4-day service fee. Passports and Chinese visas will be mailed to families via FedEx once processed. Please note that the Chinese Embassy may issue a visa valid ranging from 3 months – 2 years from the date of issue. Families are responsible for monitoring the expiration date on their visa to ensure it does not expire prior to their estimated travel dates. Any family with special circumstances should use a private courier.

### AWAA Courier Fee & Late Fee

America World's courier fee is \$25 per Chinese visa for the first two visas, and \$20 for each additional visa after two pending visa documentation is submitted by the requested date by the Travel Coordinator. Each traveler who is unable to get their visa documentation to America World by the deadline but would still like America World to process their visa will incur a late fee of \$25 per visa.

### **Chinese Visa Application Process**

- 1. Complete Chinese visa application using the "Chinese Visa Instructions" on pages 9-10
- 2. Email/fax Chinese visa application to the America World Travel Coordinator for review
- 3. Travel Coordinator sends you an email with a detailed review of the visa application
- 4. Compile passport, a copy of the passport photo page (one copy per sheet of paper), and completed visa application with standard 2x2 size passport photo attached
- 5. Pay the "Total Amount Due" on the <u>AWAA payment site</u> under Visa Payment and mail a printed copy of your online payment confirmation or include a check payable to "AWAA" with your visa package
- 6. Mail all visa items from step 4, along with your Visa Payment form (page 22) and payment, through a priority traceable mail carrier.
- 7. Send an email to the Travel Coordinator containing the tracking number for your visa package as well as the expected arrival date

### Multiple State Chinese Visa Instructions

Please fill out the visa form in its entirety and use the following detailed instructions. The form may be hand written in blue or black ink or typed.

- 1.3 Please write your Chinese Name if Applicable: This applies to persons who were adopted from China or who were born in China.   - 1. Photocopy of adoption decree
  - 2. Photocopy of Chinese passport photo page
  - 3. Chinese passport

Please refer to the photo page of your passport to fill out boxes 1.4, 1.7 – 1.13 of the application:

- 1.4 Current Nationality
- 1.5 Other or Former Name: Includes persons with maiden names or who were adopted (referral name)
- 1.6 Former Nationality
- 1.7 Date of Birth: written in the following format (YY-MM-DD)
- 1.8 Place of Birth
- 1.9 Passport Type: Most persons will have a passport marked "P" on the passport photo page. "P" type of passport is marked as "Regular"
- 1.10 Passport Number
- 1.11 Date of Issue: written in the following format (YY-MM-DD)
- 1.12 Place of Issue

- 1.13 Expiration Date: written in the following format (YY-MM-DD)
- 1.14 Your Current Occupation: All applicants must list detailed information regarding their job title beside "Other:"

If the Visa applicant traveling with you is a student, please mark the box next to "Teacher or Student" for their application. Be sure to include the school name and address in boxes 4.1 and 4.3. If the applicant is a stay-at-home mom, please list "Homemaker".

- 2.1 Major Purpose(s) of Your Visit(s) to China: Please mark the box for "Tourism"
- 2.2 Intended Number of Entries: Please mark the box for "Multi-entry valid for 12 months". Note: The Chinese Embassy may issue a visa valid for a shorter or longer period of time, depending on your application details and specifically, job description.
- 2.3 Date of your First Possible Entry into China: (YY-MM-DD):
  - Hague cases: Please write the date as three months from today's date
  - Non-Hague cases: Please write the date as one month from today's date
  - Your Longest Intended Stay in China: Please write "16" days
- 2.5 Please list Counties/Cities and Provinces to visit in China in a time sequence: "Beijing, Your Child's Province, Guangzhou"
- 2.6 Do not request rush service as visa processing takes 4 business days
- 3.1-3.4 If you mark "Yes" to any of these questions, the Chinese Embassy may required additional documentation or deny you a Chinese visa

## Chinese Visa Instructions Continued

- 3.5 This question is asking if you have ever applied for a Chinese visa previously
- 4.1 Name of Your Employer or School:
  - If you write the name of a school, please list the grade level (i.e. Elementary, Middle, High, College)
  - If you write the name of an employer, please write out the full name and include a brief description (i.e. "Bank", "Insurance company, "Real estate company", etc)
- 4.2 Please provide a phone number where the applicant may be reached during the day or before 5:00 pm ET
- 4.3 Please provide the address of the school or employer
- 4.4 Please provide a phone number where the applicant may be reached in the evening or after 5:00 pm ET
- 4.5 Please provide your home address
- 4.6 Please provide your email address (if applicable)
- 4.7 (4.7 4.10) Please write "N/A"
- 6.1 (6.1-6.4) Adults/guardians, please provide your information for any minor here, and be sure to provide your signature in box 6.4

"Applicant's Signature": Any applicant 18 years and older must sign the visa application form.

### Items Required to Receive a Visa:

- 1. Valid US passport at least 6 months from expiration, 2 blank pages facing each other, and signed (physical passport)
- 2. One recent passport photo taken within the last six months (2" x 2") Note: This does not need to match the passport
- 3. A completed and signed visa application form reviewed by AWAA
- 4. Proof of online payment for Chinese visa(s) or a check payable to AWAA
- 5. Visa Payment Form
- 6. Photocopy of each applicant's passport photo page, each on its own sheet of paper


### Important Notes:

- The Visa is a stamp placed on one of the interior pages of the passport
- Passports must be signed, have <u>at least 6 months before expiration</u> and two blank passport pages facing each other in order to obtain a visa. In addition, if you have had a name change that is not reflected on the passport or have a passport that is 9 or more years old, you will need to rush order an update or new passport
- Staple the passport photo to box in upper right hand corner of the visa application form
- Parents should sign visa applications and passports on behalf of children too young to sign
  - US Passport Agency Instructions on Signing Child's Passport: "If the child is too young to write, then one parent prints the child's name, then signs their own name, adding "(mother)" or "(father)" as appropriate."
- Individuals who work in any of the listed job fields will need to include a letter on company letterhead with an ink signature: Journalist/Photographer, Pastor/Clergy.
  - The letter must include these four points:
  - 1. The purpose/mission of the company
  - 2. Applicant's job title and details
  - 3. Purpose for visiting China (strictly for tourism and adoption)
  - 4. A guarantee that the applicant will not do any activity related to their job while in China

### Time Frame

Approximately 4-10 weeks from referral acceptance mailed to China until departure for China

This form will exempt any child 10 years old and younger from receiving vaccinations until you have returned home. At least one traveling parent needs to read, sign and notarize this document prior to leaving the US. Please leave the second line blank, but fill in the name of one parent, sign and have it notarized. Please DO NOT place either your child's English or Chinese name in the blank provided.

**\*IMPORTANT:** This waiver only applies to children ages 10 and younger; children older than 10 are still required to provide documentation of vaccination. TB testing is still required for children ages 2 and older.

### AFFIDAVIT CONCERNING EXEMPTION FROM IMMIGRANT VACCINATION REQUIREMENTS FOR A FOREIGN ADOPTED CHILD

**Statement for Parent(s):** Section 212(a)(1)(A)(ii) of the Immigration and Nationality Act requires that any person who seeks admission as an immigrant, or adjustment of status to the status of an alien lawfully admitted for permanent residence, shall present documentation of having received vaccination against vaccine-preventable diseases, specifically: mumps, measles, rubella, polio, tetanus and diphtheria toxoids, pertussis, influenza type B, hepatitis B, varicella and pneumoccocal. This section exempts from the immunization requirement a child who:

- (i) is 10 years of age or younger;
- (ii) is described in Sections F or G of sections 101(b)(1), and
- (iii) is seeking an immigrant visa as an immediate relative under section 201(b),

provided that the adoptive parent or prospective adoptive parent, prior to the child's admission, executes an affidavit stating that the parent is aware of the provisions of subparagraph (A)(ii) and will ensure that, within 30 days of the child's admission, or at the earliest time that is medically appropriate, the child will receive the vaccinations identified in such subparagraph.

The following documents are required for one-parent to travel to China:

- 2. "Adoption Trip Checklist" documents (page 13)
- 3. Power of Attorney
- 4. I-864 (Affidavit of Support)
- 5. Supporting Documents for the I-864
  - a. Certified Copy of Tax Returns
  - b. I-864 A

### One-Parent Adoption Trip Additional Documents

In addition to all adoption documents/items referenced on page 13, please bring the following one-parent travel documents with you to China.

Document Type	Description/Instructions
Power of Attorney*	The non-traveling spouse will need to fill out and sign this form. The Power of Attorney will need to go through the entire notarization, certification and authentication process (the process dossier documents go through). Once the document has completed all steps please make 4 photocopies with all certification/authentication pages. Submit one of the photocopies to AWAA, take two with you to China, and keep one for your records.
<mark>1864</mark> (Affidavit of Support)	The traveling spouse is known as the "Sponsor" and must sign Part 8 of the I -864. Please do not fill out any other portion of this document before you leave for your trip. The I-864 must be signed in the US.
<mark>1864A</mark> (if applicable)	The Sponsor will need to sign Part 2 and the non- traveling spouse will need to sign Part 3. If the Sponsor's salary meets the poverty guidelines then an I-864A will not be needed.
Certified Copy of Tax Returns	In order to verify that your family meets the poverty guidelines, you will need to provide a certified copy of your most recent year's tax returns. If spouses filed separately, a certified copy of each spouse's tax returns will be required. Fill out the top portion of the "Notarized Copy of an Original" document, page 31, and staple a copy of your tax returns to the back.
<u>1600</u>	This form must be signed on the right-hand side (under "prospective petitioner's spouse) by the <b>non-traveling spouse</b> . The document should <b>not</b> be dated or notarized. The Sponsor (travel spouse) will complete the form while in China.
Commissioner's Consent Letter (if applicable)	This form must be obtained for the Consulate appointment and is usually prepared by your home study agency. Families that live within any of the states listed above that are considering having only one spouse travel will need to contact their Home Study agency and the Travel Coordinator to begin the process of obtaining a Commissioner's Consent Letter. *This form is only required in the following states; VA, PA, AL, DE, IL, MI, ND, SD, and WI.
Foster Care License (IL Families Only)	Families from Illinois will need to bring a copy of their foster care license to China if one parent is traveling.

**\*IMPORTANT**: AWAA is only permitted to courier documents from the following states: Washington D.C., Maryland, Wyoming, Virginia, West Virginia, Delaware, Kentucky, Tennessee, Montana, Utah, North Carolina, South Carolina, Idaho, North Dakota, South Dakota, and Nebraska.
